**WHEREAS**, Wallowa County is required to supplement the budget for the 2019-20 fiscal year in order to recognize both additional revenues and expenditures, and

**WHEREAS**, pursuant to ORS 294.471 (3), following due and proper notice, the Board of County Commissioners may adopt a supplemental budget at a regular meeting, and

**WHEREAS**, the Board of County Commissioners adopted a budget for the fiscal year 2019-20 on June 26, 2019, and

**WHEREAS**, conditions have changed since the adoption of the 2019-20 fiscal year budget, and

**WHEREAS**, the Board of County Commissioners as the governing body of Wallowa County may, in accordance with Oregon Revised Statute 294.463 (1), (2), and (3), approve a transfer of an existing appropriation, and

**WHEREAS**, the Board of County Commissioners as the governing body of Wallowa County may, in accordance with Oregon Revised Statute 294.338 (3), appropriate by resolution, unanticipated revenues and expenditures, and

**WHEREAS**, the Board of County Commissioners as the governing body of Wallowa County may, in accordance with Oregon Revised Statute 294.456 (6), adjust budgeted resources and reduce expenditures to reflect a decrease in resources,

**NOW, THEREFORE, BE IT HEREBY RESOLVED** that the Wallowa County Board of County Commissioners hereby adopts the supplemental budget summarized below and makes the appropriations shown in the summary; and that the Administrative Services Director is authorized to make the budget adjustments to the 2019-20 budget as summarized below.

**Explanation of change(s):**

There is a need to recognize and receive unanticipated revenue that is reflected in the General Fund beginning fund balance of \$296,827. This amount will be added to the Unappropriated account in the General Fund.

The County received unanticipated revenue of Sale Tax Forclosure (Talbott) in the amount of \$675,000 from what was budgeted.

The County will be reimbursed for all expenses incurred for the Talbott Tax Forclosure and the remaining balance will be transfer to the Special Districts for debt reimbursement.


