**Public Notice**

Notice is hereby given of a public hearing to be held by the Wallowa County Planning Commission on Tuesday, April 28, 2020 at 7:00pm in the Thornton Conference Room, 1<sup>st</sup> floor of the Wallowa County Courthouse. The agenda for this meeting will include the following items that we tabled from last month's meeting due to COVID-19:

RAINBOW TROUT COMMUNITY SOLAR CUP#20-01 - The applicant, Pacific Renewables LLC has submitted a Conditional Use Permit application for a 4.53 acre community solar farm. The property for the proposed solar farm is zoned Exclusive Farm Use (EFU) and is described as Township 2 South, Range 44, Section 0300, Tax Lot 2601 and consists of approximately 49.2 acres. The review criteria will be Article(s) 5, 9, 15, 25, and 36 of the Wallowa County Land Development Ordinances and any other applicable goal, regulation or ordinance of Wallowa County or the State of Oregon.

RED BARN COMMUNITY SOLAR CUP#20-02 - The applicant, Pacific Renewables LLC has submitted a Conditional Use Permit application for a 12 acre community solar farm. The property for the proposed solar farm is zoned Exclusive Farm Use (EFU) and is described as Township 1 South, Range 45, Section 0000, Tax Lot 2500 and consists of approximately 431.82 acres and is more commonly known as 66520 Getting Rd, Enterprise, OR 97828. The review criteria will be Article(s) 5, 9, 15, 25, and 36 of the Wallowa County Land Development Ordinances and any other applicable goal, regulation or ordinance of Wallowa County or the State of Oregon.

Other Business:

The May Planning Commission meeting is scheduled for May 28, 2020.

These matters will be reviewed for conformance to the WCCLUP and WCLDO Article 1, Article 5, Article 7, Article 15, and any other applicable goal, regulation or ordinance of Wallowa County or the State of Oregon. All applications and draft staff reports may be reviewed in the Planning Dept. Monday – Thursday from 7:00am to 5:00pm. Written comments must be received by the Wallowa County Planning Department – 101 S River St. Room 105, Enterprise OR 97828 – by 3:00pm on Tuesday April 28, 2020. Oral comments may be given at the time of the hearing, which is open to the public.
